Website Terms of Use

1. Who we are and acceptance of these terms

These terms of use ("Terms") govern your access to and use of foretour.co.uk and app.foretour.co.uk (together, the "Site"), operated by Fore Tour ("we", "us", "our").

By using the Site, you agree to these Terms. If you do not agree, please don't use the Site.

2. What Fore Tour is

Fore Tour is a golf trip and society management tool covering team draws, hole-by-hole scoring, live leaderboards, and league tables. Fore Tour is currently in active testing with a small number of users, and features, availability, and pricing may change as it develops.

3. Changes to these Terms and the Site

We may update these Terms, or change, suspend, or withdraw the Site, at any time, particularly during this testing phase. Where a change is significant, we'll try to let existing users know.

4. Availability

The Site is provided on an "as available" basis. We don't guarantee it will always be available, error-free, or uninterrupted, this applies with particular force during the current testing period, where bugs and downtime are expected as part of active development.

5. Accounts, trip codes, and PINs

- Trip codes and scoring PINs are used to control access to a specific trip or round
- You're responsible for keeping any code or PIN you're given confidential and not sharing it beyond your group
- We may restrict or remove access where we reasonably believe a code or PIN has been shared inappropriately or used to misuse the Site
- You must be 18 or over to set up a trip or act as a Fore Tour organiser

6. Acceptable use

You must not use the Site:

- In breach of any applicable law
- To attempt unauthorised access to any part of the Site or its data
- To disrupt, overload, or interfere with the Site's normal operation
- To scrape, extract, or harvest data from the Site by automated means
- To upload or transmit malicious code



7. Intellectual property

The Fore Tour name, logo, and branding, and the content and design of the Site, belong to us or our licensors. You may view and use the Site for its intended purpose, but you may not copy, reproduce, or reuse our branding or content for any other purpose without permission.

8. Handicaps and scoring – important note

Handicap index values in Fore Tour are entered directly by each player and are not verified against WHS, England Golf, or any official handicap database. Fore Tour is a tool to support scoring and social competition organised by you and your group, it is not an official scoring or handicap record, and results should not be relied on for any purpose requiring an officially verified score.

9. Payments and pricing

Fore Tour is paid for on a pay-as-you-go basis, billed to the trip organiser or society contact rather than to individual players. Current pricing is published at foretour.co.uk/pricing and may change from time to time; the price shown at the point of booking applies to that booking.

Payment is collected via a secure payment link, currently provided through Revolut. We do not receive or store your card details – these are handled directly by our payment provider.

Golf Trips and Society bookings both use the same rate: £2.00 per player, per round for the first 3 rounds, then £1.50 per player, per round from round 4 onwards. Golf Trips are paid upfront at booking, once player and round numbers are confirmed. Society bookings are paid upfront for each batch of rounds as they're added to the season.

We don't offer refunds for on-the-day no-shows. Any player slots paid for and not used carry over to your next booking with us.

Prices shown are not currently subject to VAT.

11. Cancellations and events outside our control

12.

If you need to cancel a Golf Trip or a society round after paying, let us know as soon as possible. Where you cancel with at least 7 days' notice before the round, we'll refund what you've paid within 5 working days, or roll it over to a future booking, whichever you'd prefer. Cancellations within 7 days of the round, or after it has started, are not refundable, though unused player slots can still roll over as set out above.

Where a round can't go ahead for reasons outside anyone's reasonable control – course closure, severe weather, or similar – we'll work with you to reschedule and roll the payment over to the rescheduled round, rather than refunding.

Neither we nor you will be liable for any failure or delay in performing our obligations under these Terms where that failure or delay results from circumstances beyond our reasonable control, including extreme weather, industrial action, or failures of third-party services we rely on to run Fore Tour.

13. Third-party services

The Site may link to or rely on third-party services. We don't control and aren't responsible for the content or availability of any third-party service.



14. Liability

Nothing in these Terms limits liability where it would be unlawful to do so, including for death or personal injury caused by negligence, or for fraud.

Subject to that, and to the fullest extent permitted by law, we exclude liability for indirect or consequential losses, or losses arising from reliance on the Site during this testing phase, including loss of data from bugs, downtime, or database resets that may occur during active development.

15. Governing law

These Terms are governed by the laws of England and Wales, and the courts of England and Wales have exclusive jurisdiction, subject to any applicable consumer protections.
